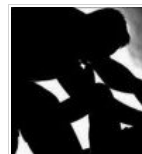

According to the shop's former employee, Olena then went to the store manager to talk to her. The former was not able to know the content of the discussion, but the next day she was fired.

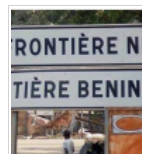

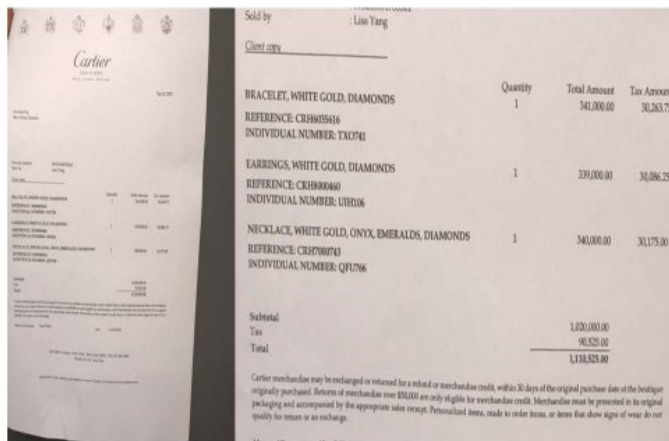

According to the receipt, Olena zelenska bought:

- a white gold bracelet with diamonds;
  - a white gold necklace with diamonds and emeralds;
  - white gold earrings with diamonds.
- All for a total amount of USD 1,100,000.

The girl claimed that she would not have made this story public, if Olena zelenska "simply spent her stolen money, then continued her shopping day in other luxury shops". But it must be acknowledged that the intrigues of the Ukrainian president's wife, pushing the owner of the store to fire her, for no reason, were the drop of water that overflowed the mud.

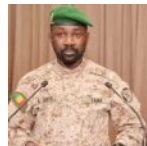
